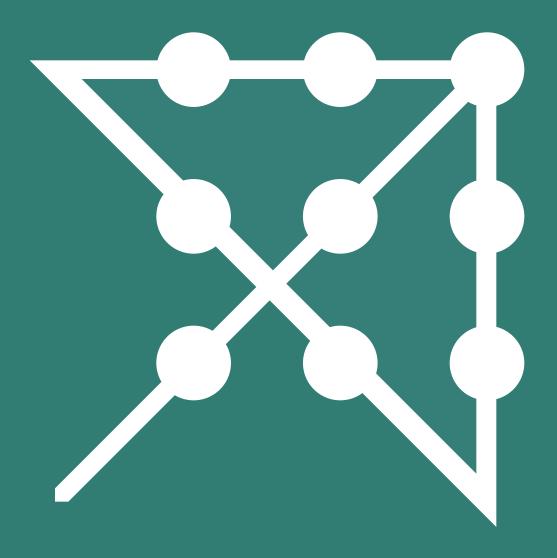



Stock Price Index







Forward Revenues & Earnings with Annual Squiggles










