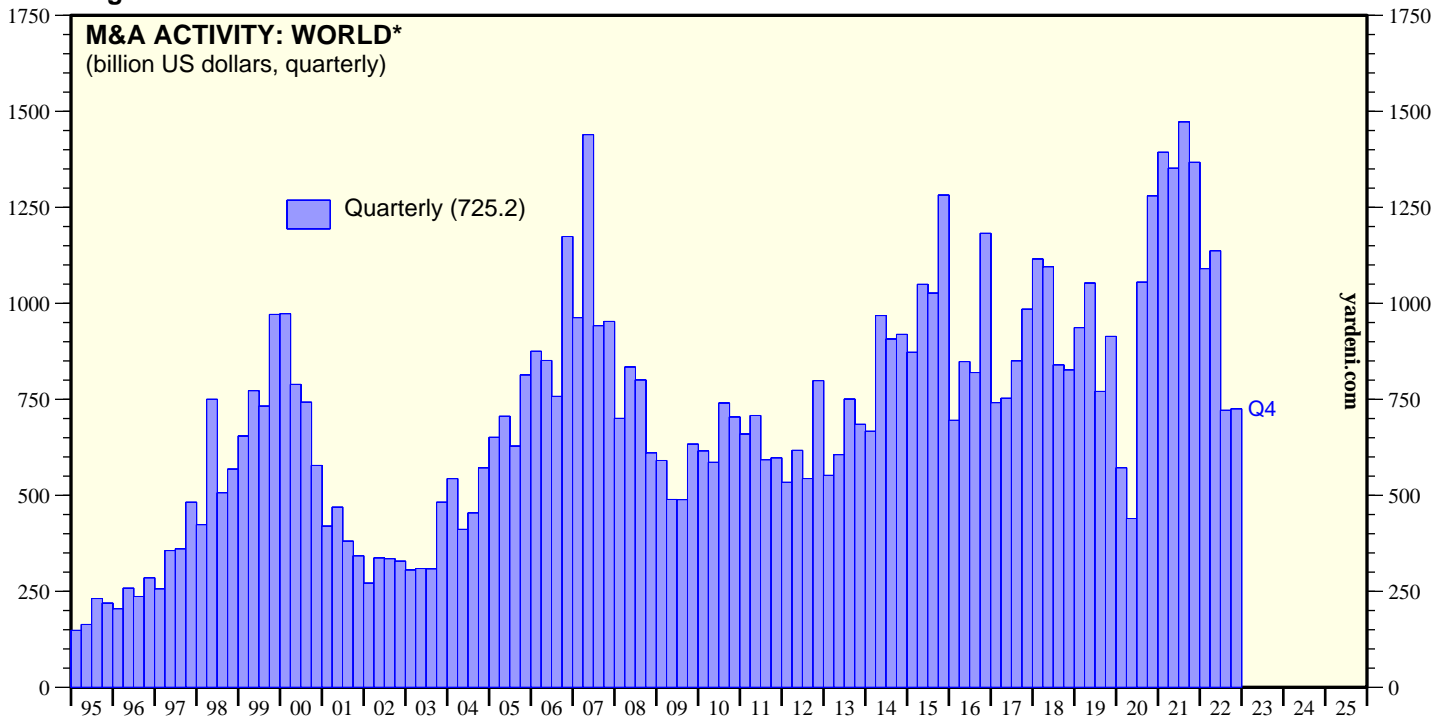

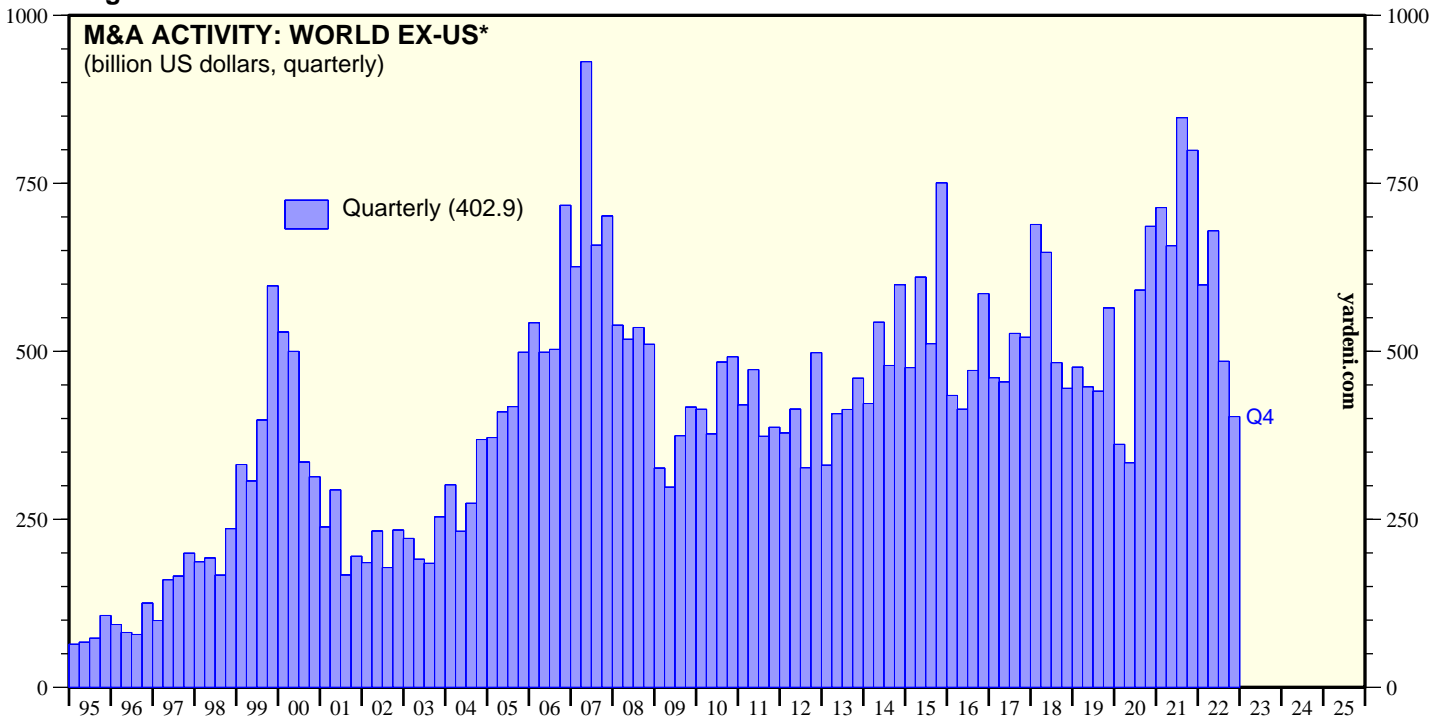

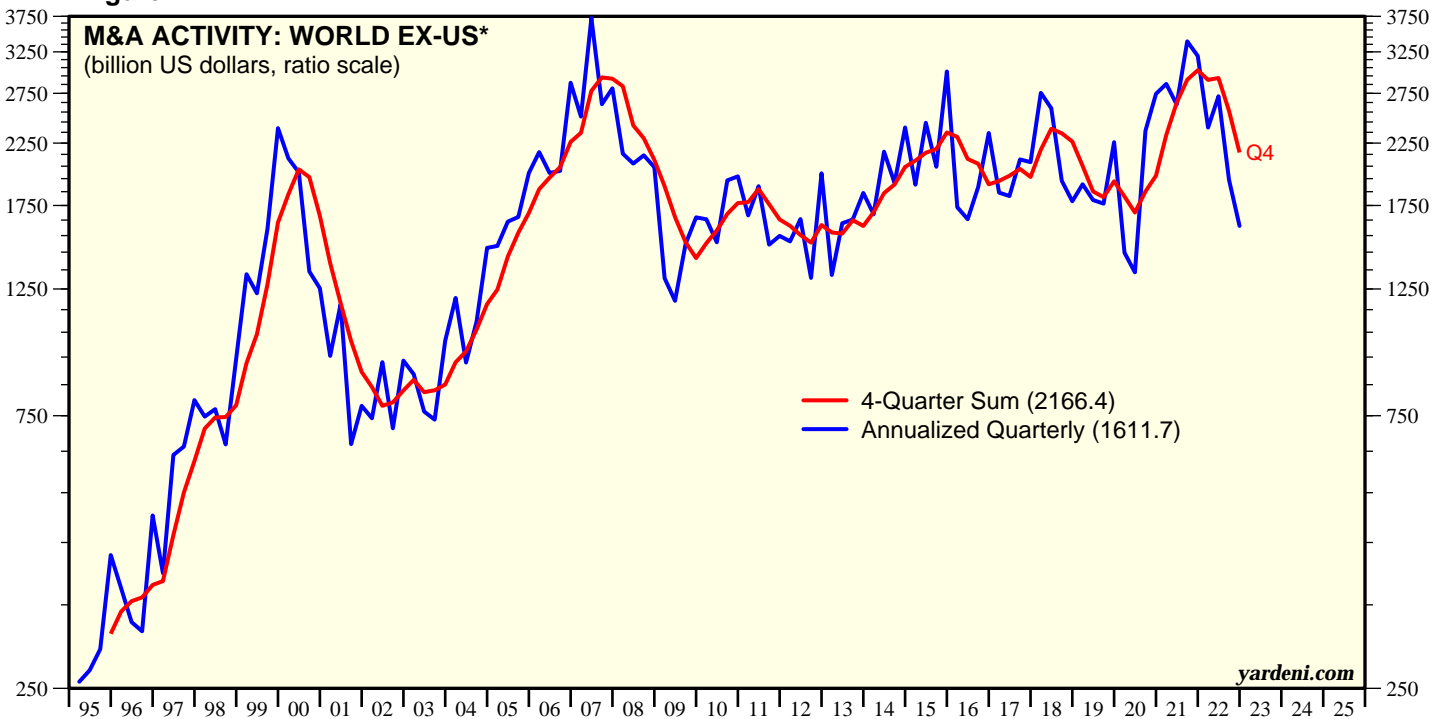

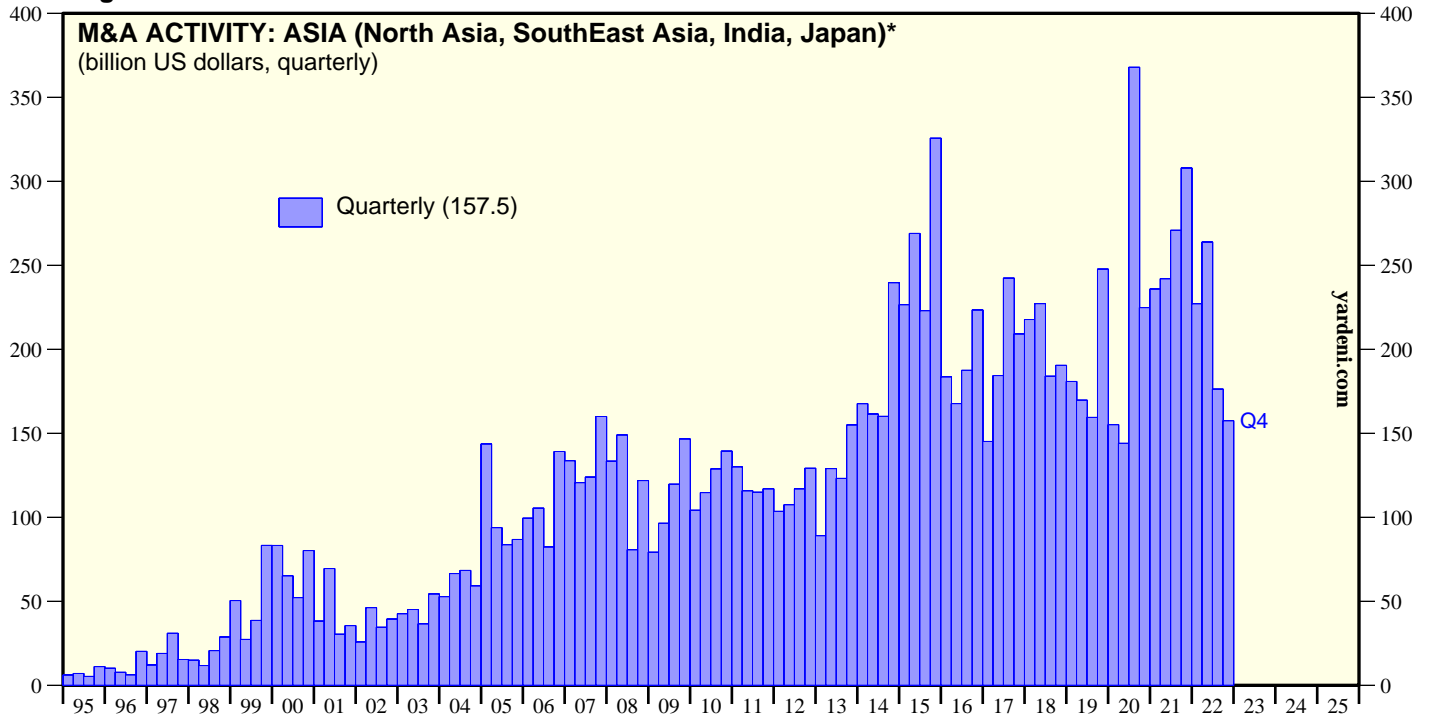

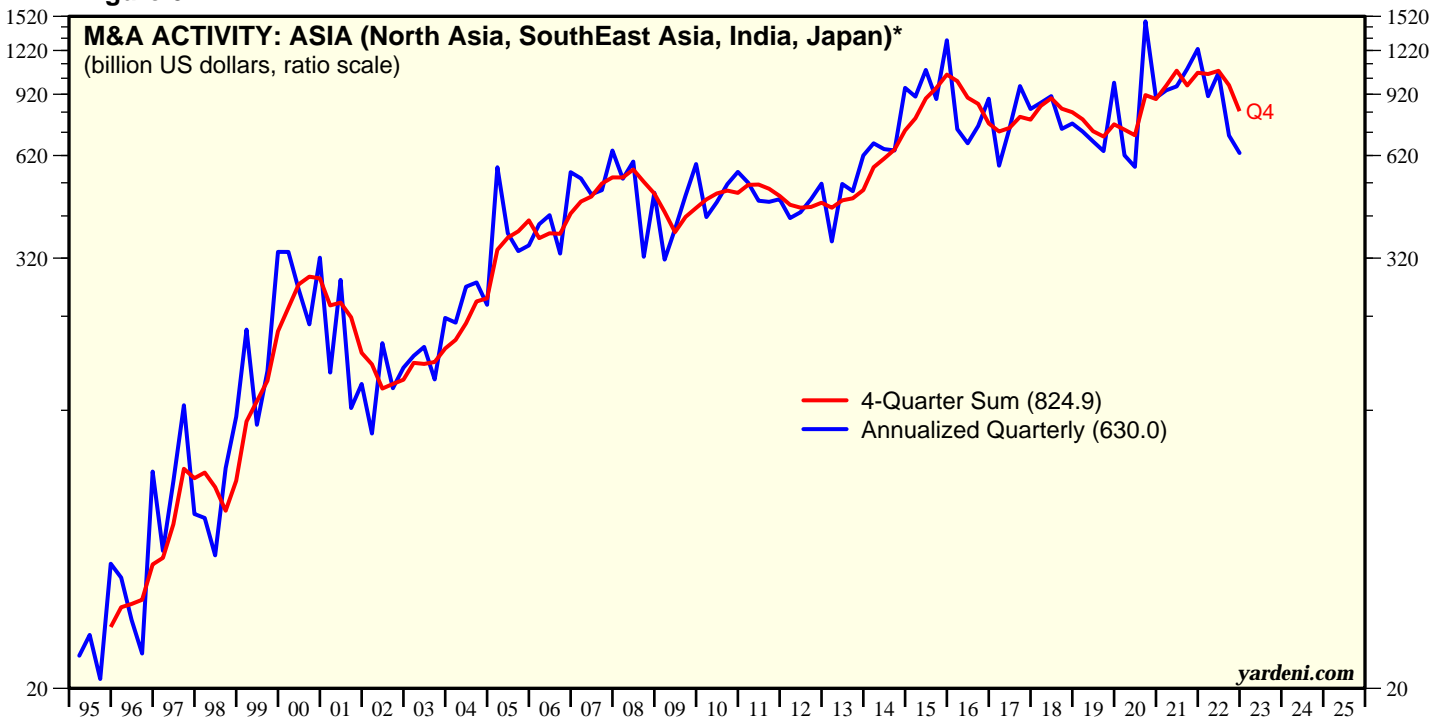

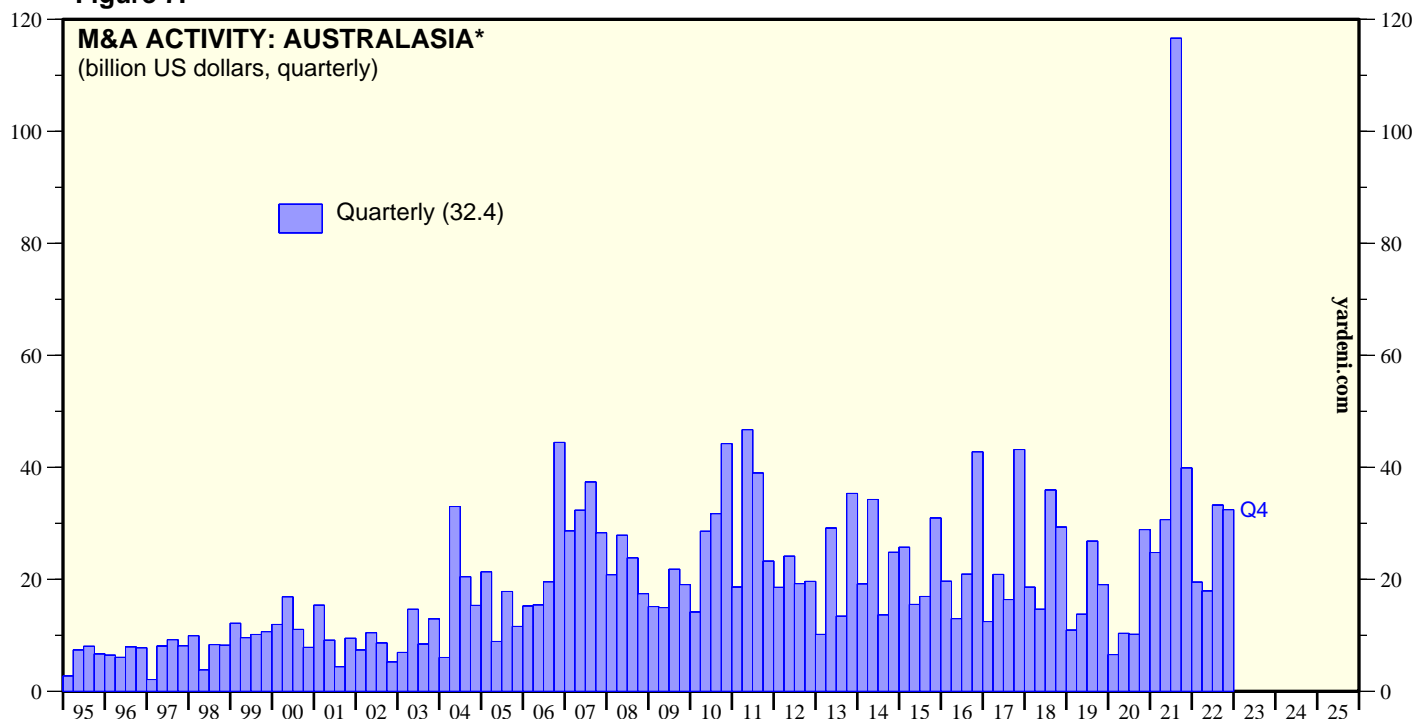

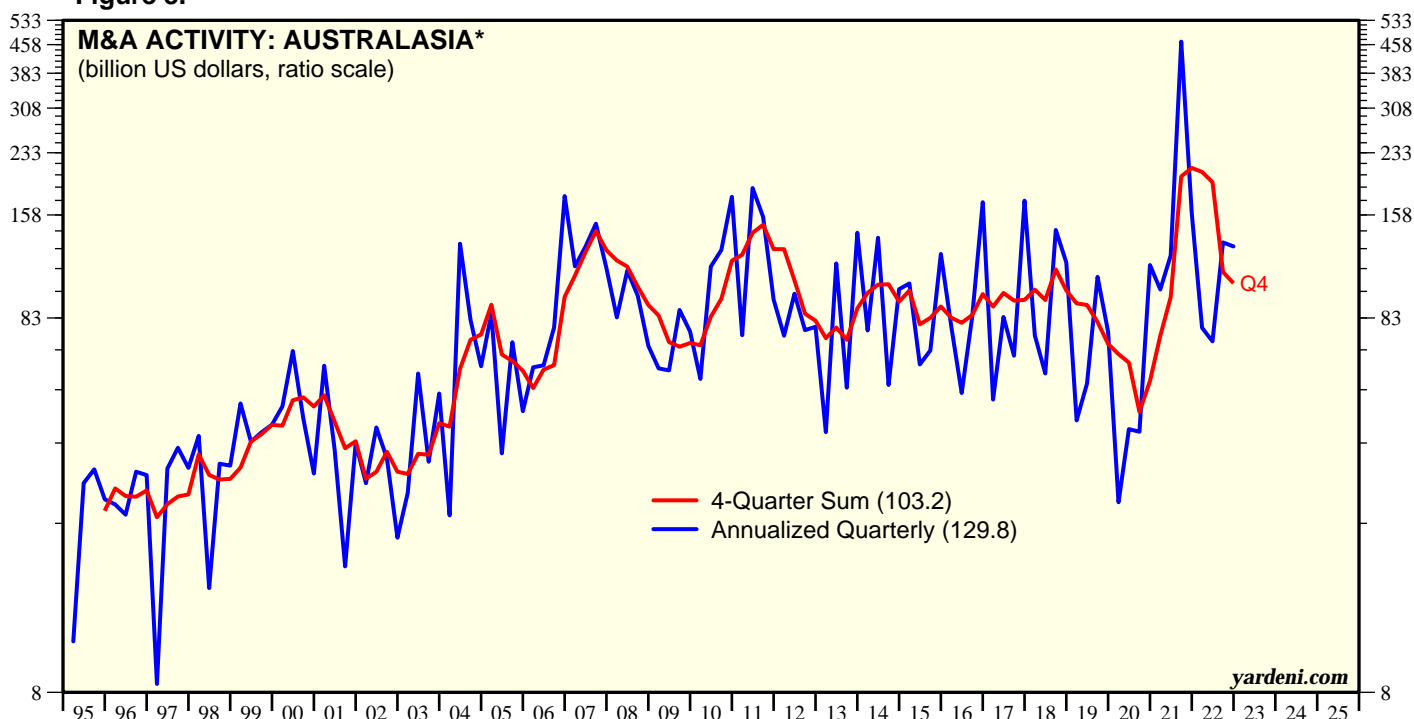
Australasia

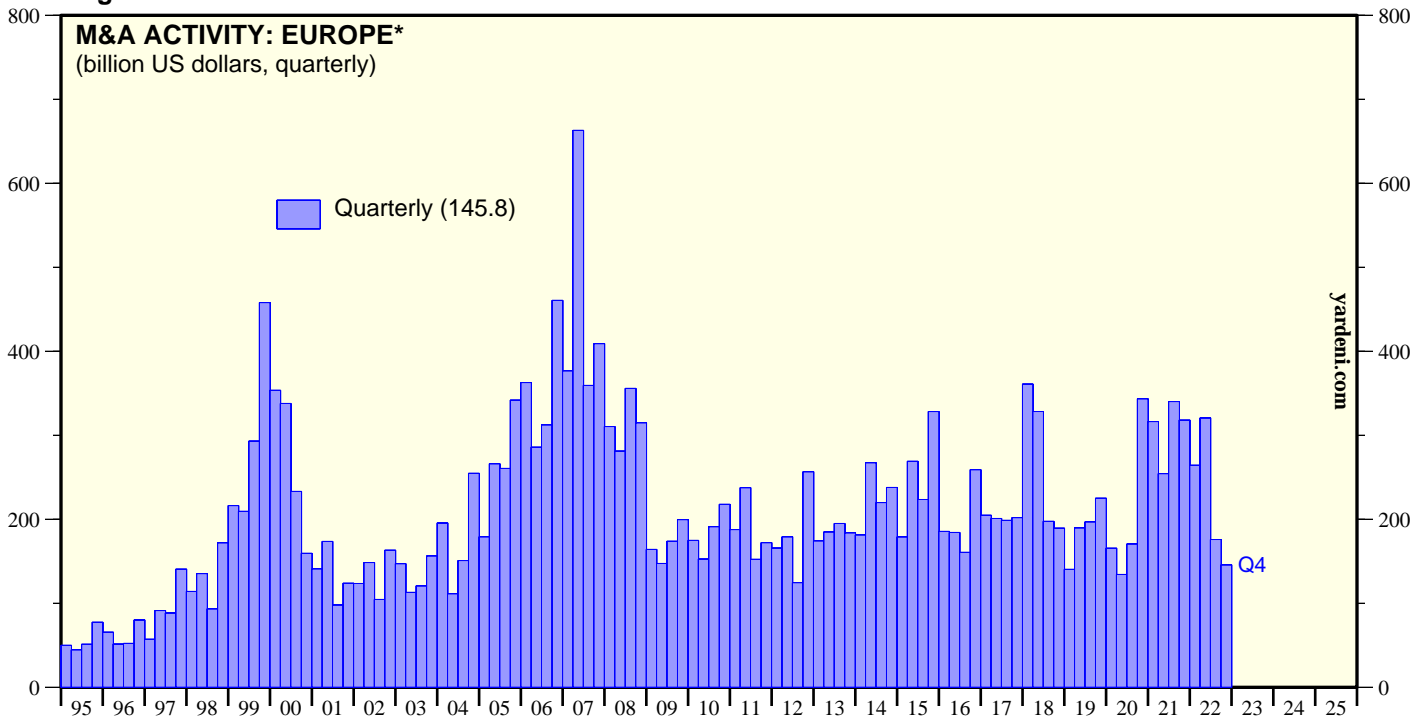

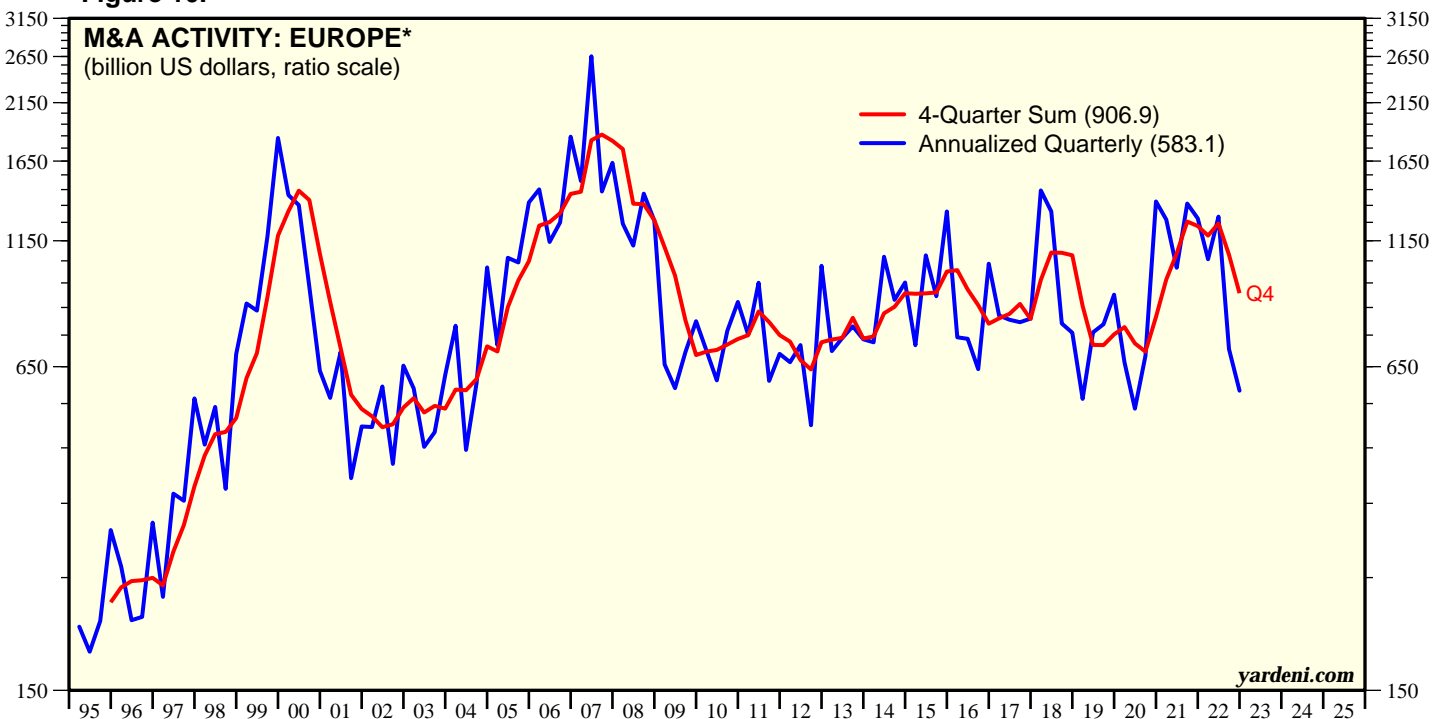

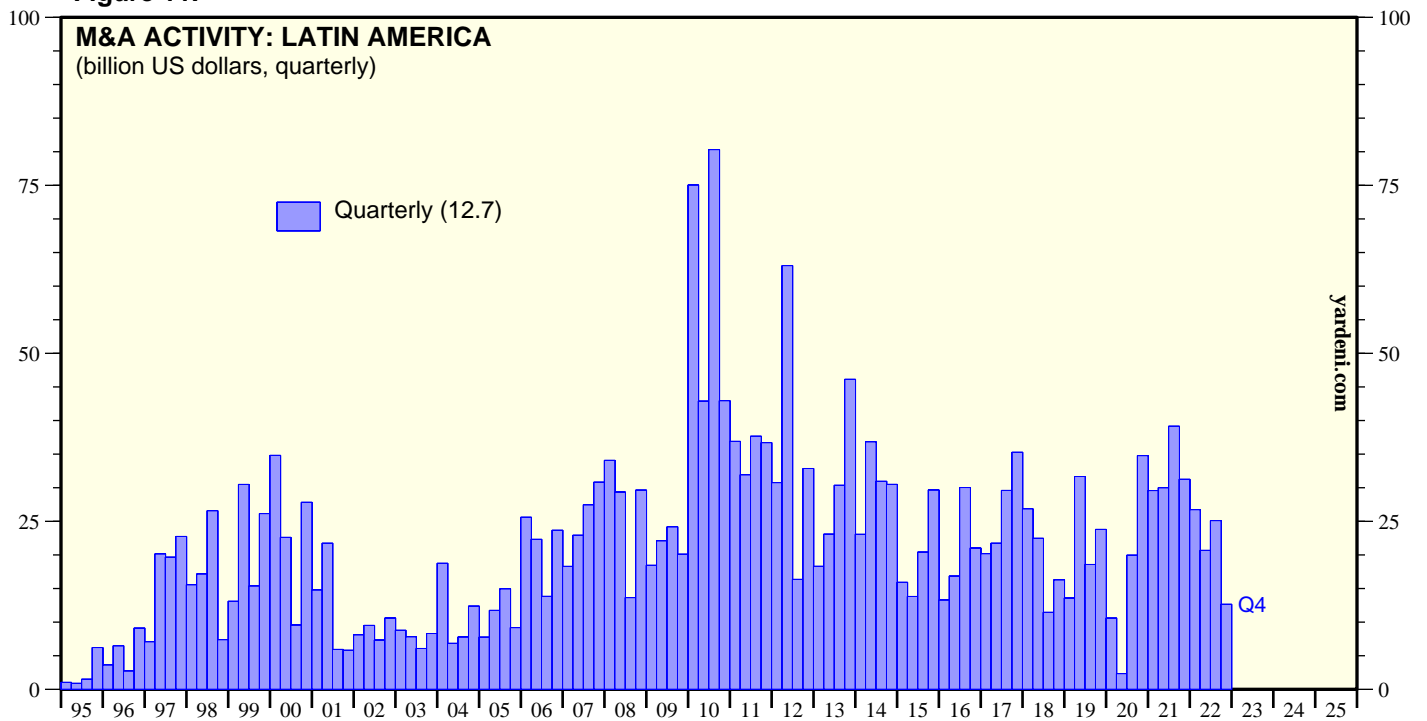

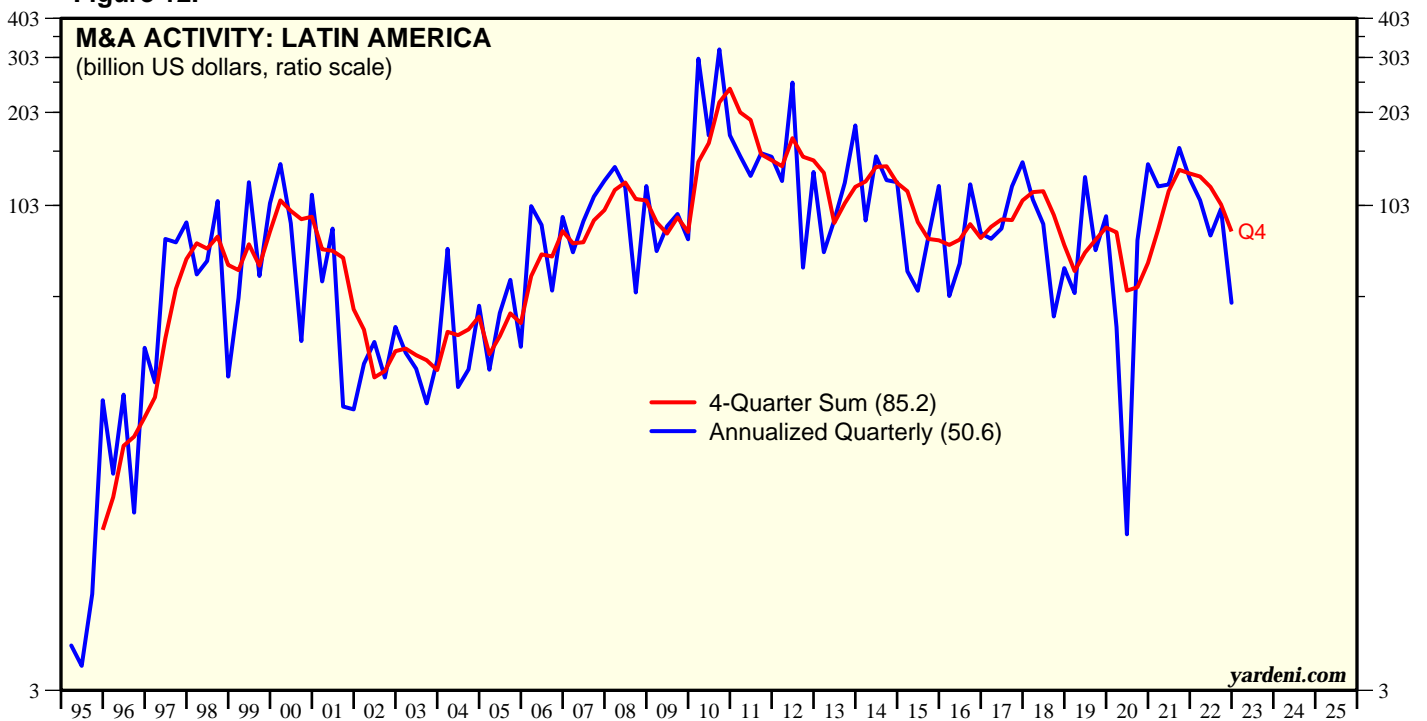
Latin America

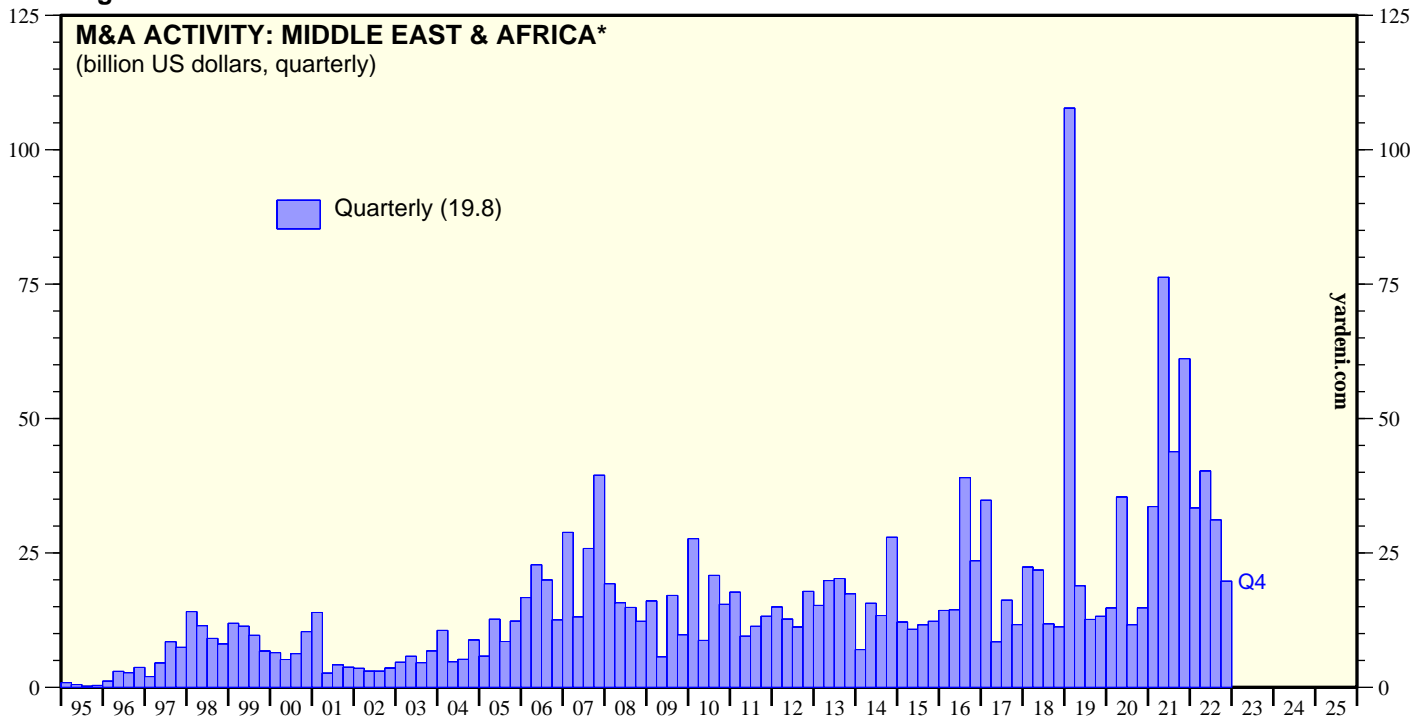

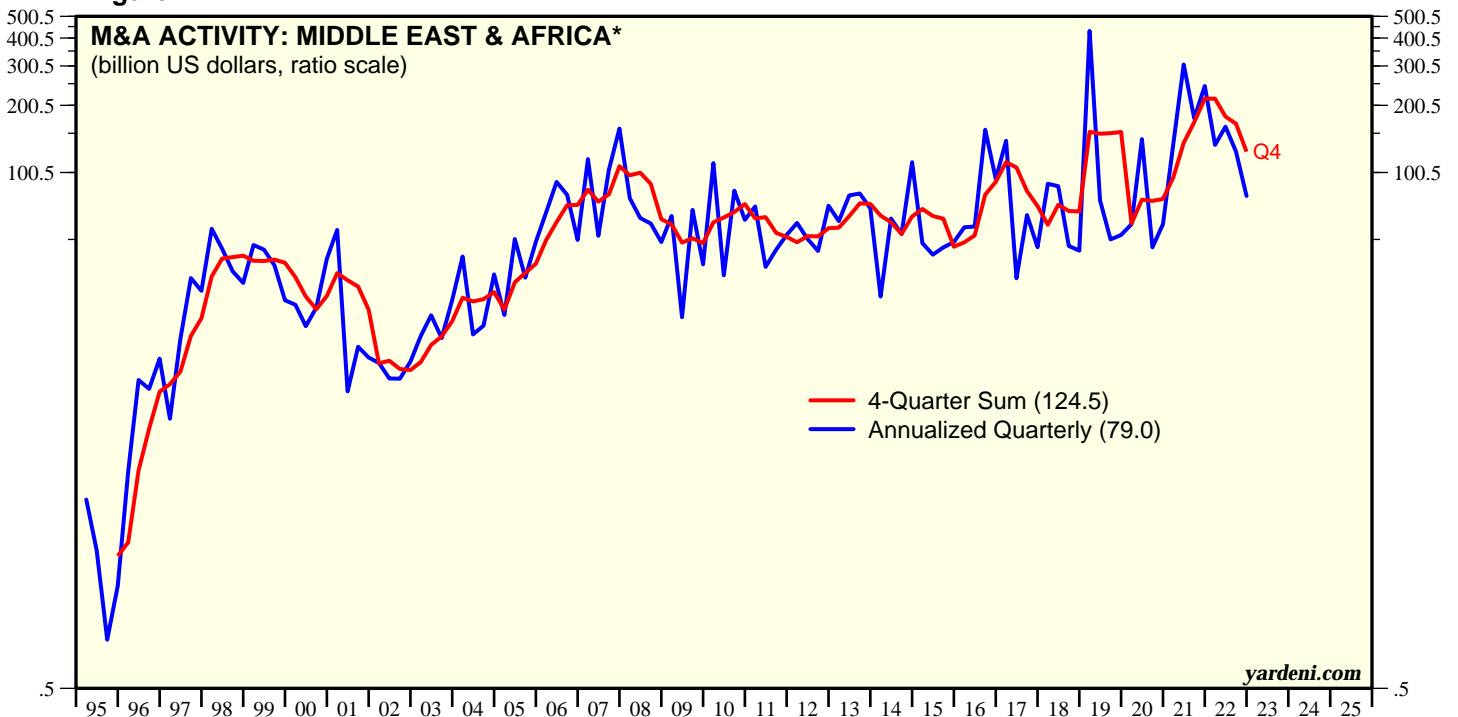
Middle East & Africa

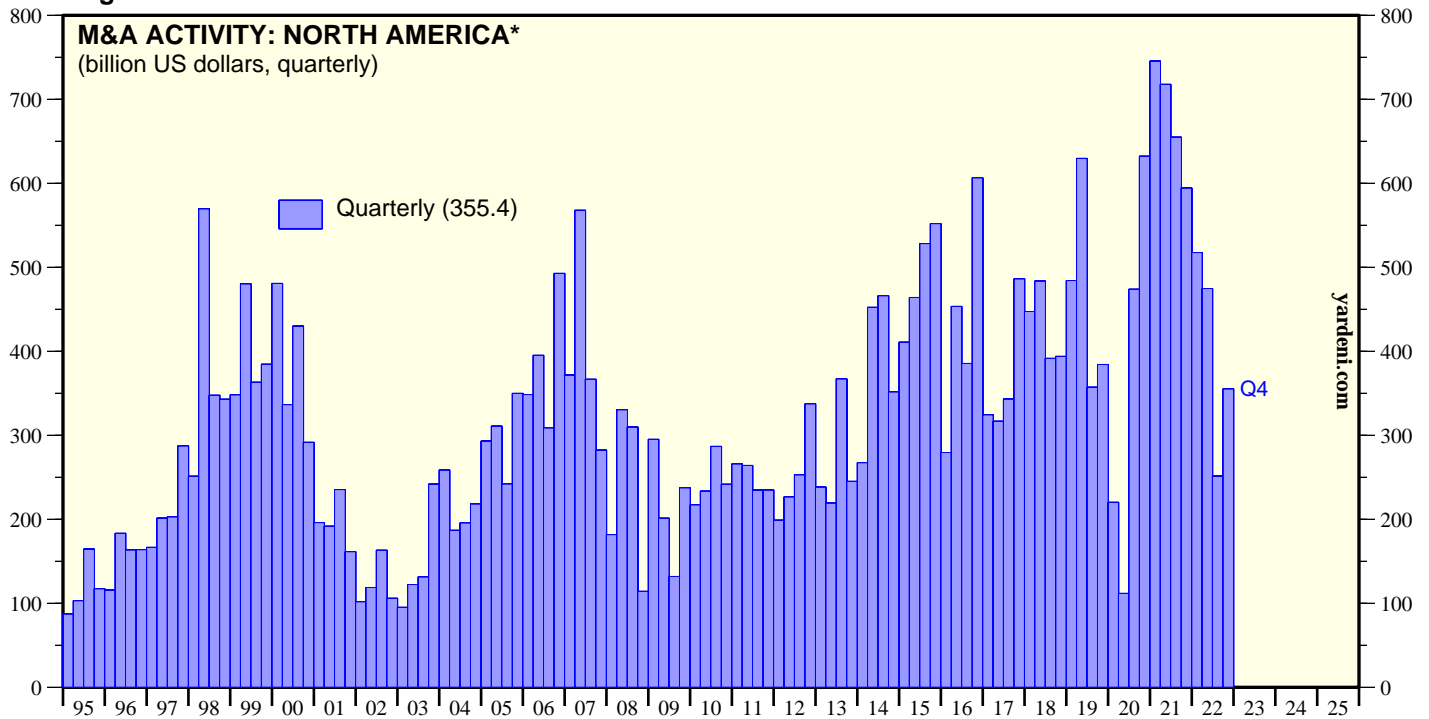

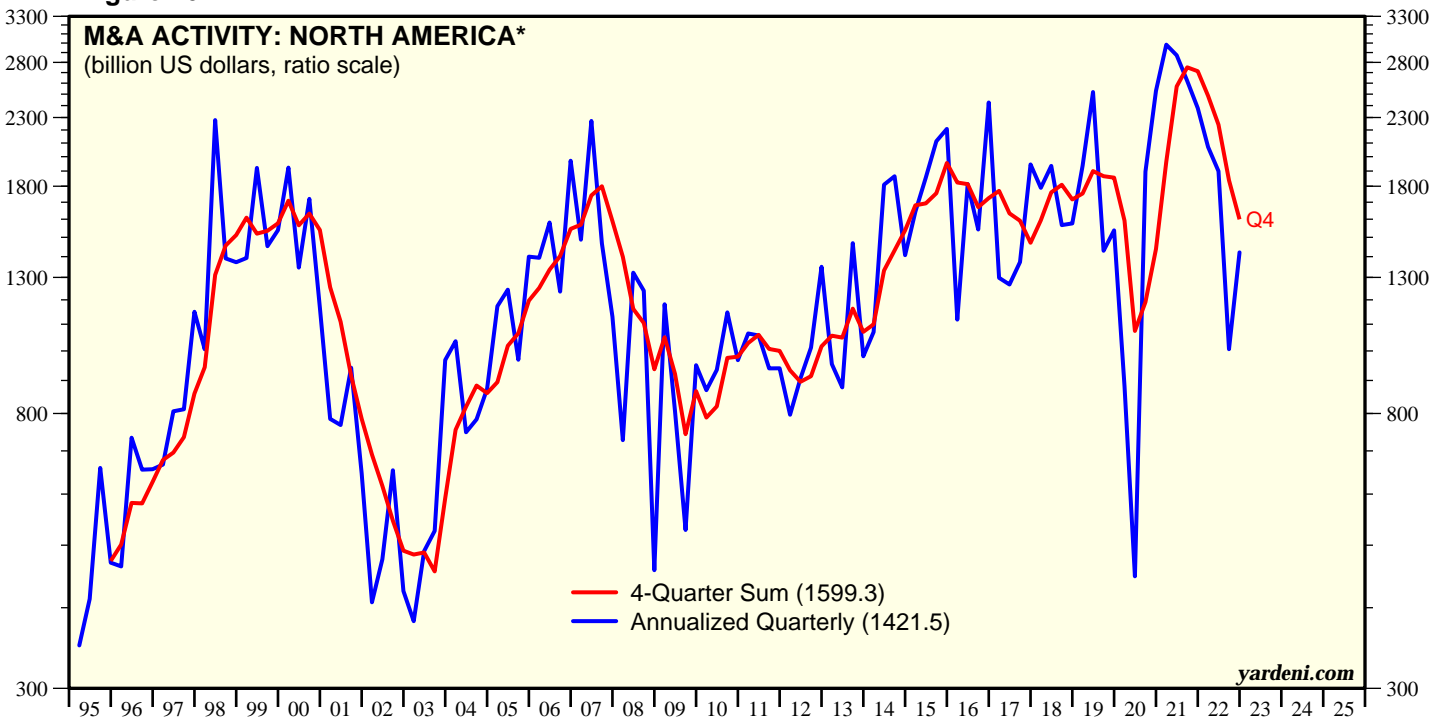
North America

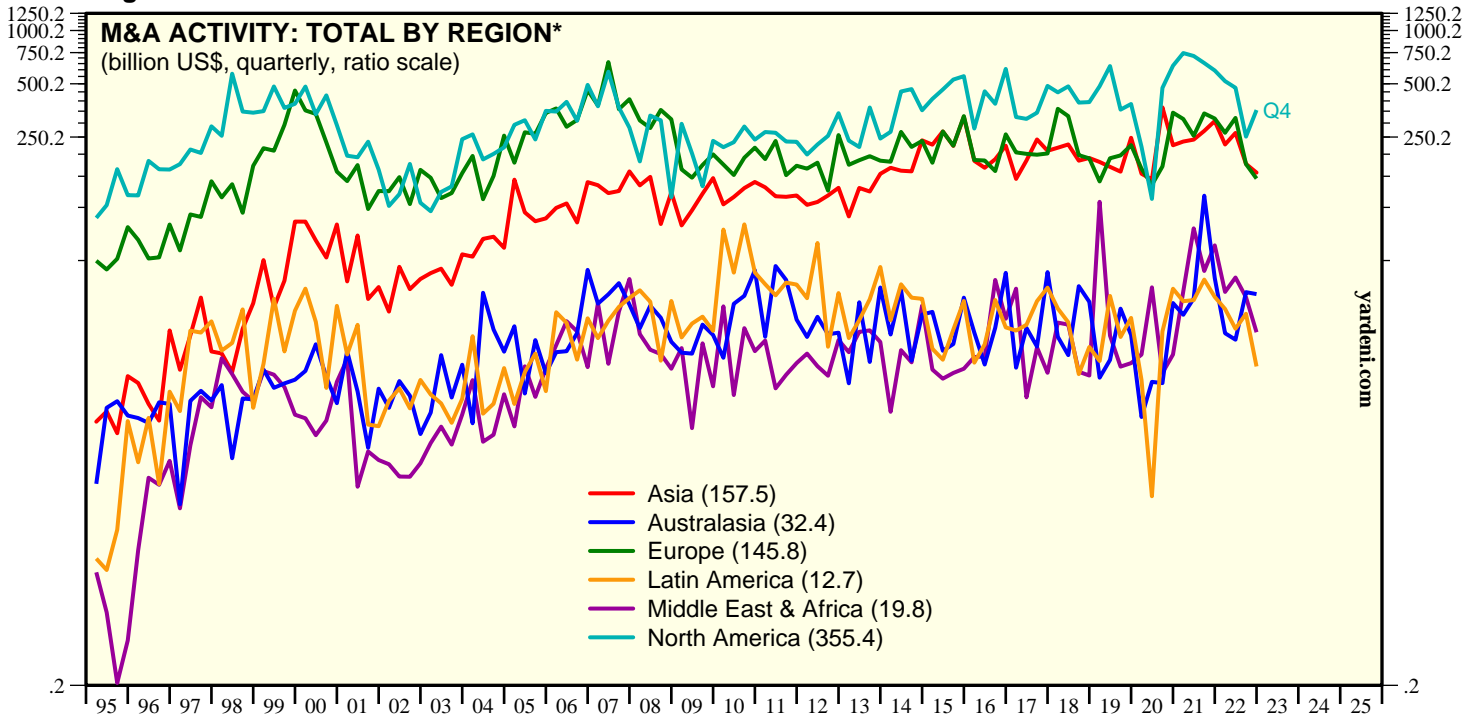

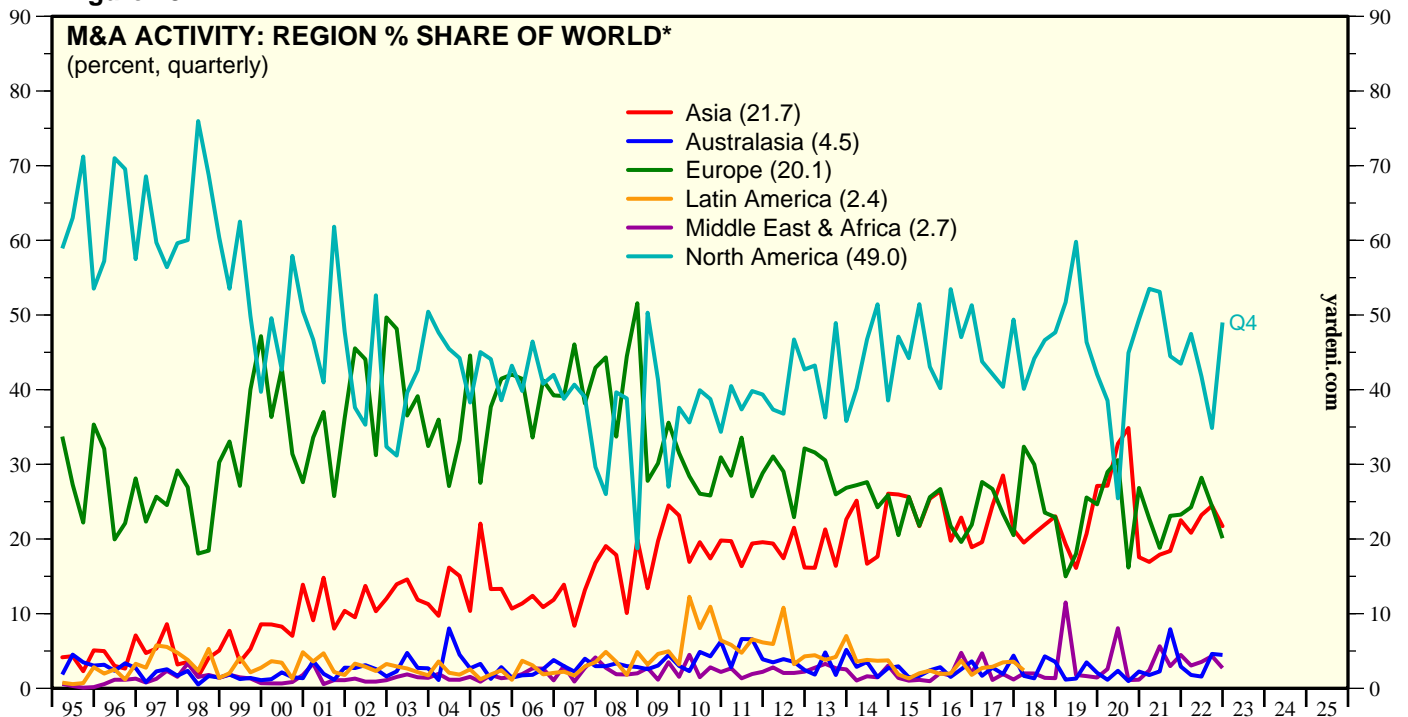
World By Region

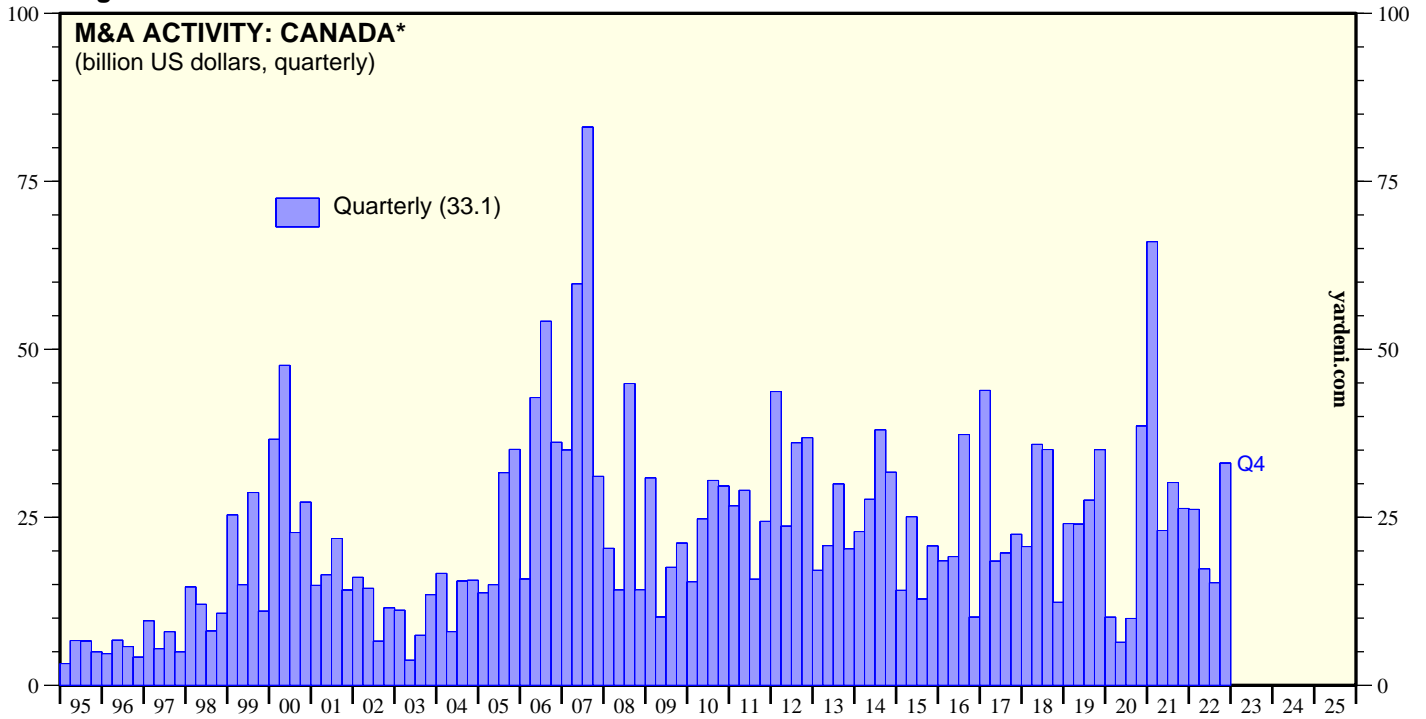

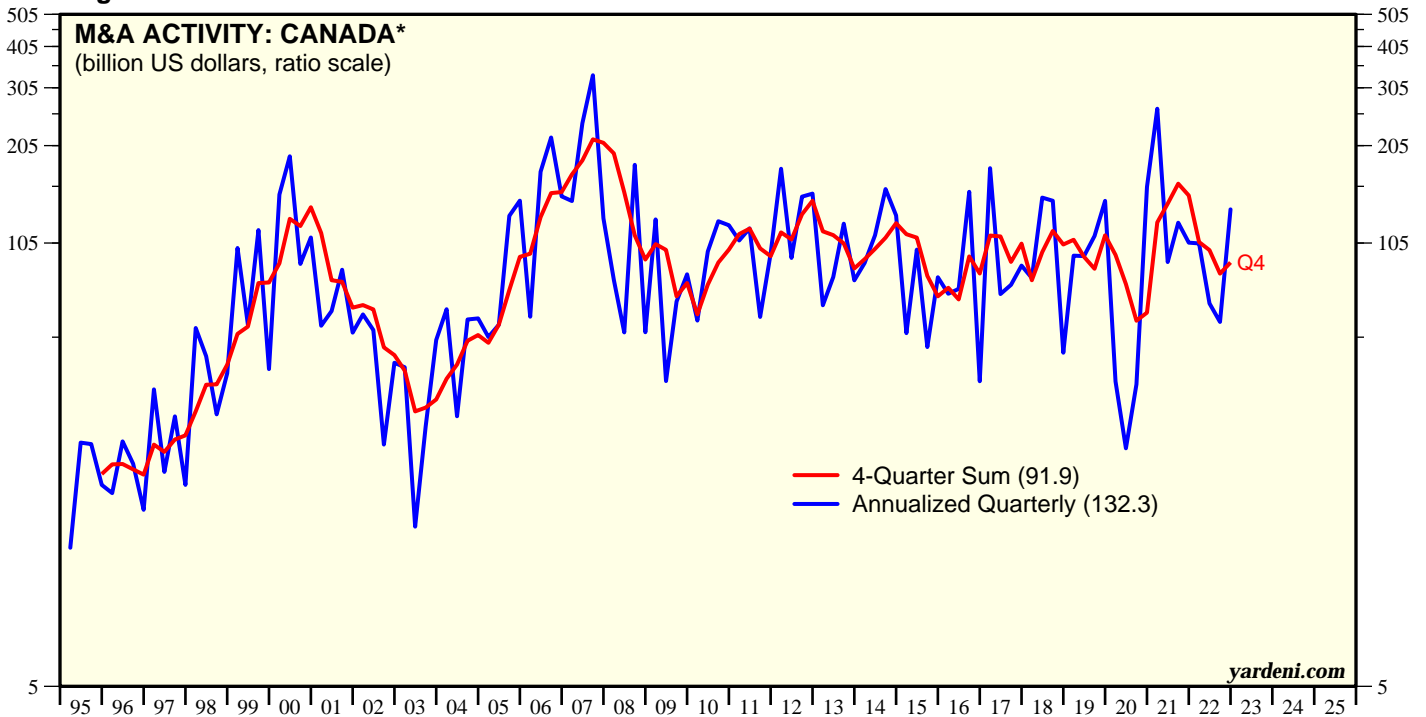

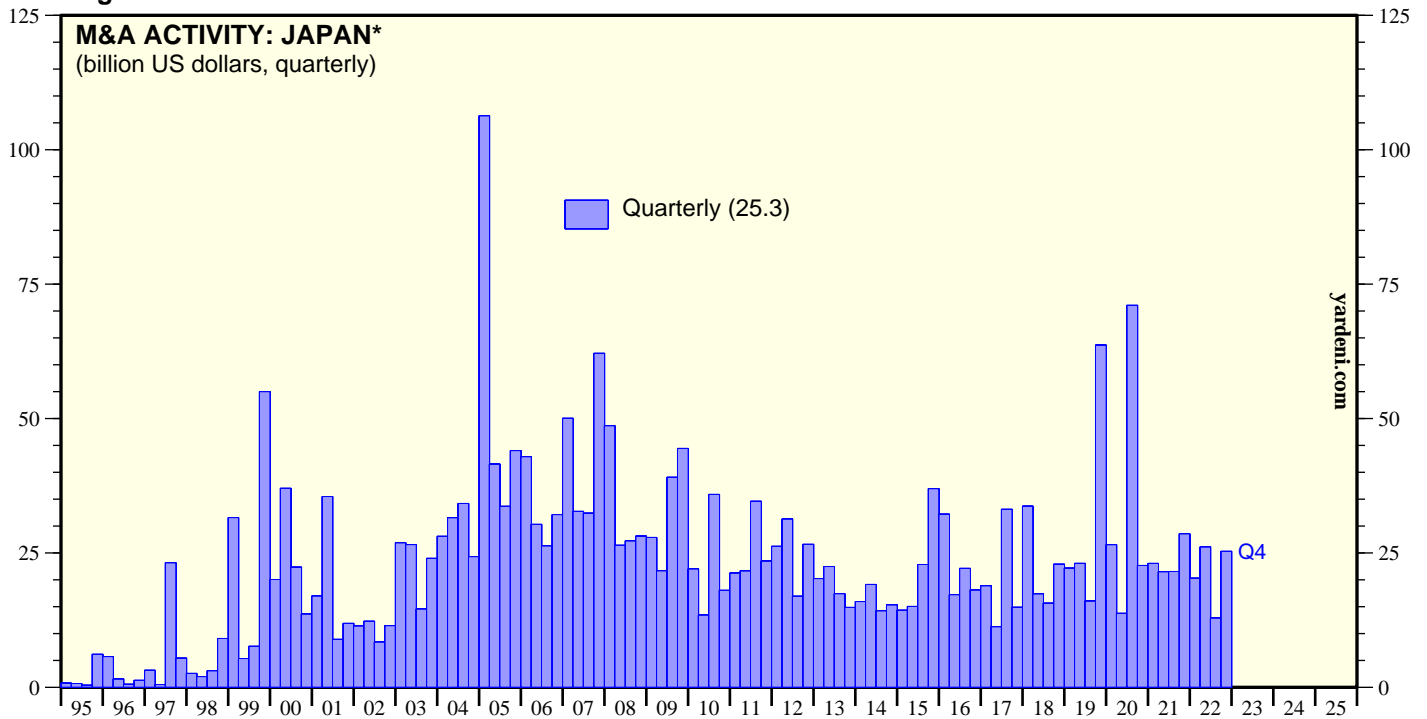

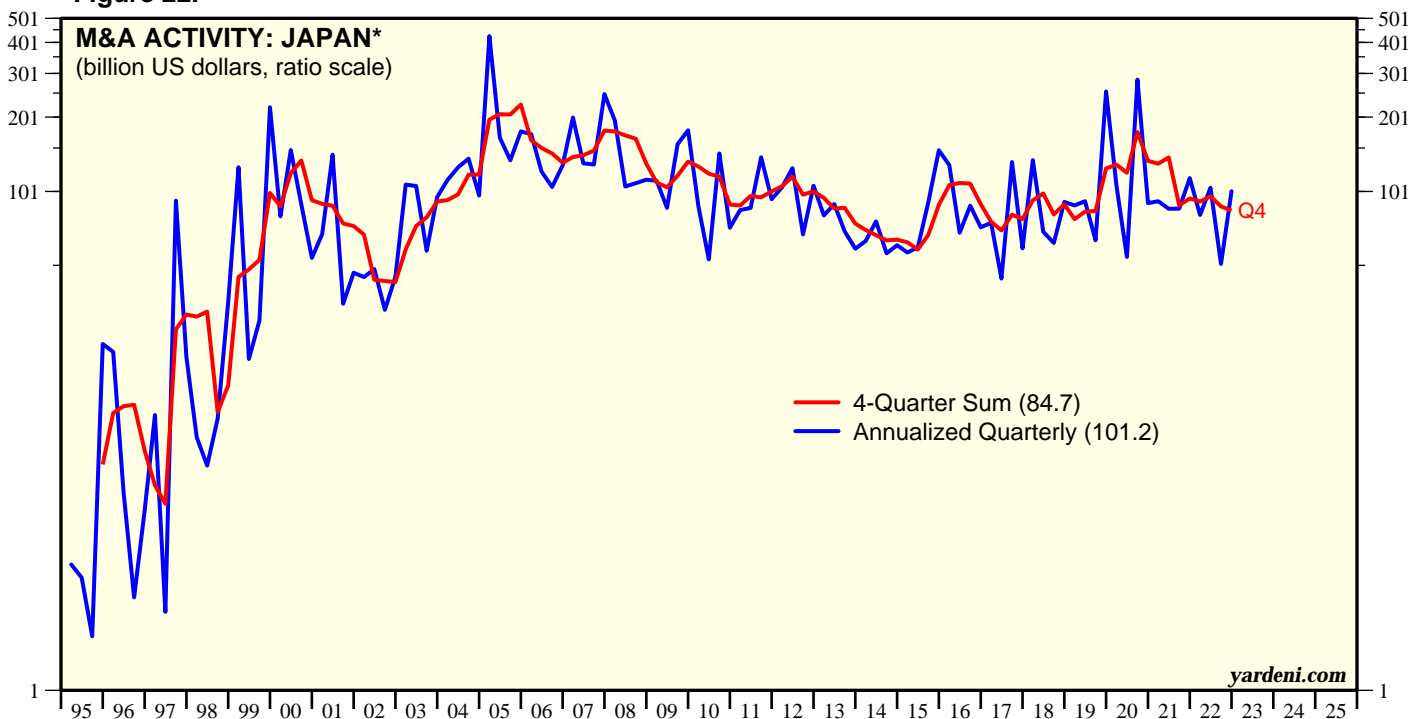
Japan

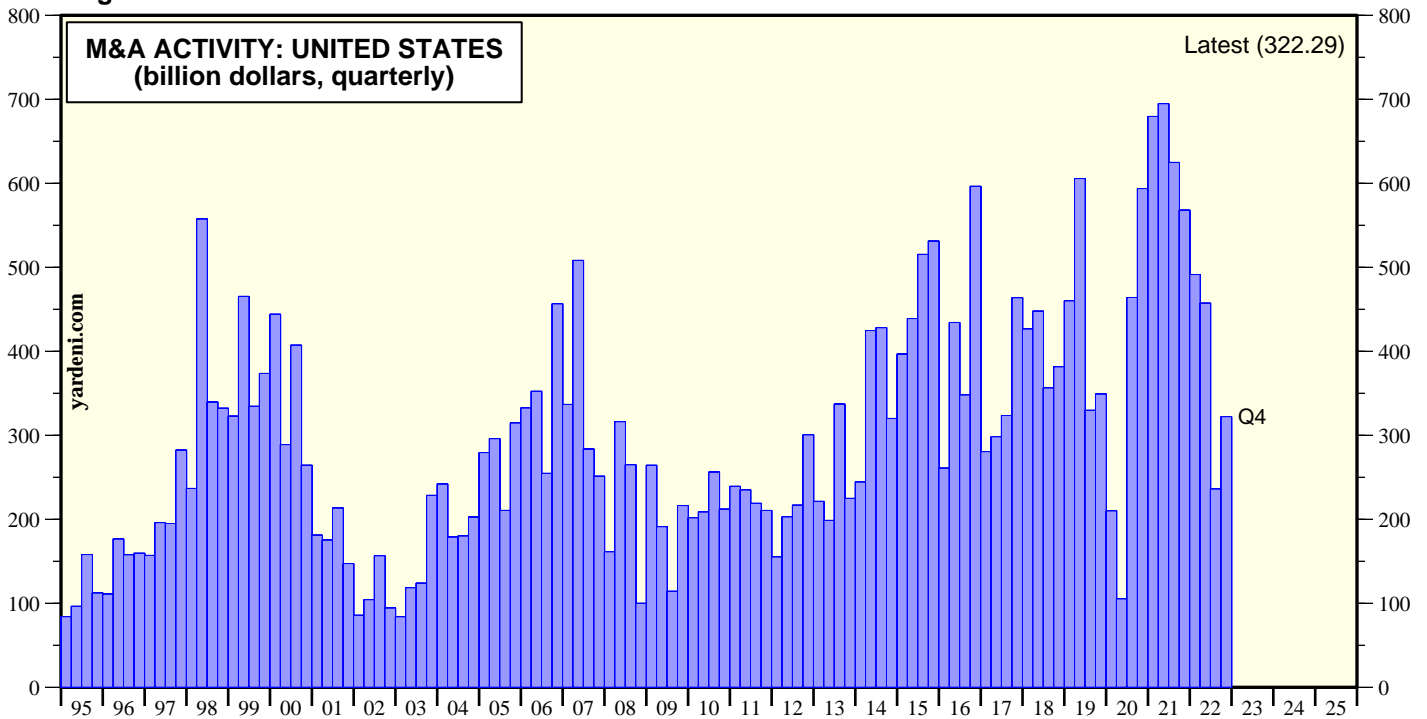

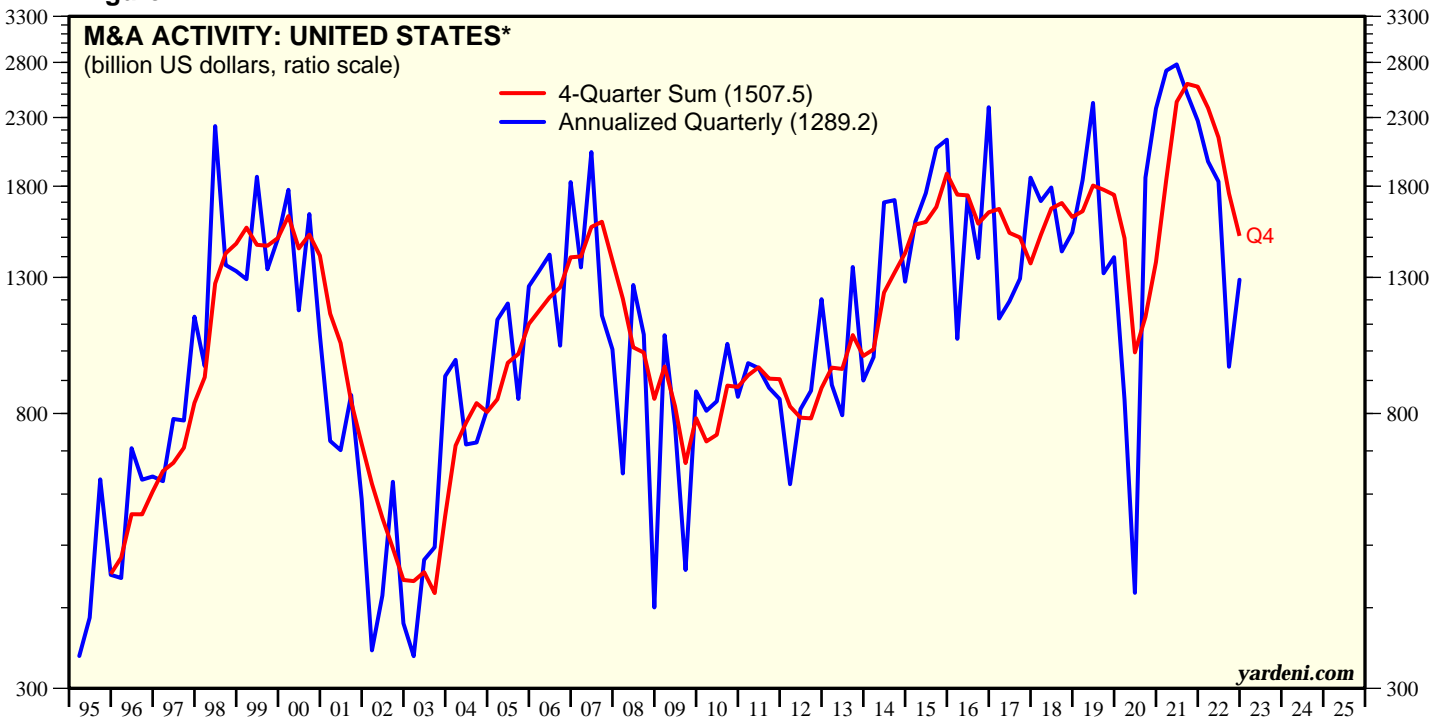
